Please bear with us as we continue to navigate the challenges associated with the Covid19 Virus. We will continue to monitor changes with the State, Local and Barn Hunt officials. Specific Covid 19 rules, if any, will be published in the Judging Program.

By entering these trials, you attest that you have read and will abide by the following waiver:

I certify that I do not, to my knowledge, have COVID-19 at the time of attending this event, nor have I knowingly been in contact with or exposed to any person with COVID-19 within the past 10 days. I have not been told to isolate or quarantine. I am not awaiting the results of a COVID test. If I have been diagnosed with the virus or have had virus-like symptoms but no formal diagnosis, I certify that I have been released by government officials and/or my health care providers to resume all activity with no limit and have had no symptoms for a minimum of 10 days prior to the Event. *Dogs are required to have a Barn Hunt Registration number to show in Barn Hunt. Register your dog online at: www.barnhunt.com. Allow at least 48 hours to receive a Barn Hunt number. Handlers are responsible for entering and writing legibly the correct Barn Hunt number for their dog on entry form. An incorrect number may result in any legs earned being forfeited.

(White, cement-block building on the southeast corner. Parking lot on the east side.)

- **From the North:** Take 43 South to 94 East to 794 South to Howard Ave exit. Go Left 1 block to Pennsylvania Ave. Turn Left on Pennsylvania Ave. Go 1 block to Cudahy Kennel Club on the right.
- **From the South:** Take 94 West (head North) to Howard Ave. Exit right on Howard Ave. and continue until Pennsylvania Ave. Turn Left on Pennsylvania, 1 block to Cudahy Kennel Club on the right.
- **From the West:** 94 East to 794 South to Howard Ave exit. Go Left 1 block to Pennsylvania Ave. Left on Pennsylvania Ave. 1 block to Cudahy Kennel Club on the right.

The running order and further scheduling details will be emailed to all exhibitors no later than **Friday Feb 17th** after the actual number of entries is known for each class. If you do not receive an email by Thursday night, please contact the trail secretary. Dogs will be run in height order; dogs being handled by the same person will be separated into different staged groups.

Awards: Ribbons will be awarded for all qualifiers in all classes. Ribbons will be awarded for 1st-4th place in each height division of the A & B classes. A High In Class Award will be offered in each A & B class. Title Ribbons will be awarded to all dogs earning a title.

EXHIBITOR INFORMATION:

All entries must be accompanied by entry fees to be valid. A returned check does not constitute a valid entry. Entries must be on a valid entry form - either BHA form or the form attached to this entry. There will be a \$50.00 fee for all returned checks. Make checks payable to CAPER. Send entries & fees to the trial secretary. Maximum of 10 dogs per envelope.

No phone entries. You can submit entries via email with payment at www.caper-dogs.com/BarnHuntPayPalCCpayment.htm.

Exhibitors are responsible for complete, accurate and legible information on entry forms; illegible or incomplete entries cannot be entered in the trial.

Move-ups will be allowed from Trial 1 to Trial 2 each day and from day to day. Move-ups must be submitted in writing to the secretary's desk as soon as it is determined that the dog can be moved (to either the same level B class or the next higher level A class).

Refunds: Entry fees will not be refunded in the event that a dog and/or owner/handler is absent, disqualified, excused, or barred from competition by action of the Event Committee. No entry fee will be refunded if the trial cannot open or be completed by reasons of riots, civil disturbances, fire, acts of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.

Entry fees for sick/injured dogs may be refunded after closing, less \$5.00 per run. Refunds must accompany a letter/email from your veterinarian.

Bitches in Season are eligible for entry but will be required to be kept separate from all other dogs and will be run in panties at the end of their class.

No refunds for bitches in season will be made after the closing date.

If bringing a bitch in season, please inform the trial committee prior to the trial and you must inform all exhibitors at the judge's briefing.

SITE INFORMATION:

Trial grounds will consist of the entire grounds of Cudahy Kennel Club and extend to the hotel.

There will be indoor crating at this trial.

There is **NO SMOKING** in this facility or on the grounds. If you must smoke, you will need to do so inside your vehicle and dispose of the butts in the vehicle.

Dog exercise area: Please pick up after your dog and dispose of waste in appropriate containers outside the building (green dumpster). Please be considerate about picking up after your dog(s) and leaving the grounds as you found them. Any exhibitor failing to do so may be excused from the trial grounds without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement per BHA regulations.

Food: The club will NOT have food for sale. Food/snacks will be provided for workers. There are fast food restaurants within a short drive.

TRIAL INFORMATION:

Check in each day will be between 7:00 and 7:45 am. There will be a general briefing. Judging begins promptly at 8:00 am.

Proposed running order/Judging Assignments

Ring 1: Instinct, Novice 1, Novice 2, Open 1, Open 2, Crazy Eights, Senior 1, Senior 2 – Susan Chapman / Sat & Liz Hawkins / Sun

Ring 2: Masters 1, Masters 2. – Liz Hawkins / Sat & Susan Chapman / Sun.

Entry Limits: Each day's entries will be closed when the judging limit reaches 7 hours or MVR of 210. Entries received after that point will be wait-listed. If any entries are withdrawn, the wait list entries will be taken in the order received to fill the trial to 7 hours of judging. **Any waitlisted entry that is not accepted into the trial will be refunded in full. Entries withdrawn and replaced with a waitlisted entry will be refunded in full. Any other refunds will be handled as noted above in the Refunds section.**

Collars and Leashes: Electronic collars and devices, muzzles, head halters and bark collars are not allowed on test grounds. No flexi-leads are allowed on the grounds. Handlers may choose to use one collar/restraint in the blind and a different one to enter the ring. If that is the case, the dog must enter and wear both collars/leashes in the blind, with one being removed prior to arriving at the ring. In no circumstance can a dog ever be without a secure collar/leash in the blind.

Dogs MUST run "naked," without a collar/harness. Dogs should be brought to the ring with collars/harnesses that are easily & quickly removed and replaced. All dogs must be on leash at all times except when in the ring. Dogs will never be tied out or otherwise left attached to something other than a human.

Dog Behavior: Dogs that are loud and disruptive may be asked to move away from the rings / staged areas where dogs are getting ready to compete. Dogs/handlers who are so disruptive in the blind that they disturb other dogs to the extent that the other dogs performances will/may be adversely affected may be dismissed from the blind by a Trial official and/or the Judge of Record. If the dog cannot be brought under control, the dog may be dismissed from the class and/or Trial. Any dog behaving in a threatening or aggressive manner toward another dog or a person maybe dismissed from the trial, if justification is found, by the judge and / or trial committee. Terrier sparring is not allowed on the grounds.

The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are able to navigate the courses safely.

It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and / or children. Any exhibitor whose dog(s) and / or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, may be asked to leave the trial site. In that case, no refund of any fees paid will be made.
