

COVID-19 Liability Release Waiver

The World Health Organization has declared the novel Coronavirus (COVID-19) a worldwide pandemic. Due to the capacity of this virus to spread from person-to-person through respiratory droplets, the Centers for Disease Control and Prevention, and Federal, State and Local Governments have set recommendations, guidelines, and some prohibitions with which **Cudahy Kennel Club, Inc.** intends to comply.

In consideration of my participation, in person, with elective dog training activities arranged by **Cudahy Kennel Club, Inc.** the undersigned acknowledges and agrees to the following:

Your Initials: _____ I am aware of the risk that by my physical presence and participation in dog training activities, I and my dog may become infected with diseases such as, but not limited to, Influenza, MRSA, and COVID-19. I understand an infection with one or more of these diseases may lead to illness and death.

Your Initials: _____ Should I, or any member(s) of my household, including my animals, become ill with symptoms of COVID-19 or another communicable disease, or test positive for COVID-19 or another communicable disease, during the course of ongoing participation in dog training with **Cudahy Kennel Club, Inc.**, I promise to refrain from attending training in person.

Following the pronouncements above I hereby declare the following:

I am fully and personally responsible for my own safety and actions. While and during my participation in dog training activities I recognize that I may be at risk of contracting COVID-19 or other communicable diseases.

With full knowledge of the risks involved, I hereby release, waive, and discharge **Cudahy Kennel Club, Inc.**, its board, officers, independent contractors, affiliates, employees, representatives, successors, and assigns from any and all liabilities, claims, demands, actions, and causes of action whatsoever, directly or indirectly arising out of or related to any loss, damage, injury, illness or death, that may be sustained by me while participating in any activity that may lead to unintentional exposure or harm due to COVID-19 or other communicable diseases.

I agree to indemnify, defend, and hold harmless **Cudahy Kennel Club, Inc.** from and against any and all costs, expenses, damages, lawsuits, claims and/or liabilities arising either directly or indirectly from, or related to, any and all claims due to injury, loss, or death from or related to COVID-19 or other communicable diseases.

By signing below I acknowledge that I have read the foregoing Liability Release Waiver and understand its contents; that I am at least eighteen (18) years old and fully competent to give my consent; that I have been sufficiently informed of the risks involved and give my voluntary consent in signing it as my own free act and deed; that in signing this Liability Release Waiver I intend to be bound by the same, and this consent is free of any inducement.
